### **INTRODUCTORY NOTES ABOUT THIS PRE-CONSENT**

1. This note is not the pre-consent certificate.
2. The pre-consent is issued on the understanding that the Company named in the Pre-consent Certificate ("the Certificate") is authorised to process waste at the stated facility and has an appropriate environmental permit ("the Permit") which is issued under appropriate legislation. Nothing in this document may be construed as varying the Permit, and if there is any ambiguity between this document and the Permit, the Permit will take precedence.
3. The pre-consent, is issued in accordance with Article 14 (1) of Regulation (EC) 1013/2006 on shipments of waste ("the Regulation").
4. Notifications for shipments to the facility specified in the Certificate of waste detailed in Schedule 1 for recovery using the technologies/processes detailed in Schedule 2 may benefit from the derogations from Articles 9, 10 and 12 of the Regulation as set out in Article 14(2) and (4) of the Regulation, in accordance with the pre-consent.
5. The pre-consent is limited to the period stated in the Certificate only, and may be withdrawn or revoked by the Environment Agency at any time. All revocations will be confirmed in writing by issue of a Notice. The Notice of revocation shall contain details of the reason(s) why the pre-consent has been withdrawn/revoked.
6. All international shipments of waste to the facility stated in the Certificate must comply with the procedures for prior notification and consent, as required by the Regulation.
7. The pre-consent may not be transferred to other recovery facilities operated by the same Company.
8. Any application for amendment or renewal of the pre-consent must be made in writing to the Environment Agency at International Waste Shipments, Richard Fairclough House, Knutsford Road, Warrington, WA4 1HT.
